



Athens Airport: El Venizelos



DOPING CONTROL

Doping Control follows the international rules of WADA and CMAS Anti-doping code.

FLAGS

National Teams should bring two (2) National flags (m 2,00 x m 1,00) and a CD or USB with the National anthem (short, lyric edition)

SPECIAL NOTES

- As some of the actions will take place according to the competition finishing time, final program
 will be announced at the technical meeting before the competition from the CMAS Technical
 Delegate.
- The event is open to the athletes aged 18 and over and belonging to National Teams fully complying with the provisions of CMAS Regulations.
- National Teams may be made up of several athletes but will apply a maximum of 4 athletes per country for each men's discipline and a maximum of 4 athletes per country for each women's discipline. Medalist athletes from last year WC, are not included in the quota of 4 athletes
- Masters are not counted in the limitation of 4 athletes.

- CMAS, the Competition Director, Competition Officers and the Technical Delegate are not responsible for accidents or damage caused to people and personal effects before, during or after the competition. The organizer ensures the presence of medical assistance.
- The rules of competitions applied will be:

CMAS Freediving International Rules Depth Competition

- Athletes must be in possession of:
 - The entry form at CMAS portal
 - Valid CMAS freediving sports license
 - ADEL certificate
 - ON LINE license for Masters
 - Insurance
 - Medical certificate not older than 12 months
 - ID document- Passport.

Athletes that fail to provide the above documents will not be allowed to take part in the competitions, and their participation fee will not be refunded. Also, athletes have to fulfill all the liability release documents concerning the competition.

1. CMAS Registration

Pls notice that all entries as National teams must be made by the Nationals federations.

TO TAKE PART IN THE COMPETITION MUST:

- Need to know the Rules and Regulations of the CMAS (Procedures and Obligations, Freediving depth rules)
- Register as a competitor through the CMAS Portal from your federation
- Log into CMAS portal https://portal.cmas.org/cmas/dashboard
- Go to the event section https://portal.cmas.org/cmas/evt-events/events
- Use the filter options to find the event you want to register.
- You have to register your teams through every federation official account at cmas portal
- If there is a participation from a country without federation then an individual application for a super license is possible following the CMAS procedures.

Masters Registration

Masters' registration will be done individually from each master athlete at the relevant event page. Masters' registration is final only after the payment online of 51 euros or else it will remain on the waiting list and will not be included at the competition.

2. LOC Registration and Participation fees

Registration period: starting May 1 to July 30

Registration fees without accommodation for athletes:

Until July 30th euro **750** per athlete

After August 1st +10% in the above price

Registration fees without accommodation for coaches – officials - assistants:

Until July 30th euro 350 per person

After August 1st euro 400 per person

GENERAL INFORMATION



Only participants with a CMAS license are eligible to compete in the Championship.

The registration of participants means that they accept and respect the championship rules, the safety conditions set by the organizers and the CMAS rules and regulations.

Each country may enter a maximum of 4 athletes per age category/ discipline/men/women.

Medalist athletes from last year WC, are not included in the quota of 4 athletes.

Masters have no limitations on athletes per country.

Entries must be submitted to CMAS portal within deadlines https://portal.cmas.org/login.

Registration has to be done through National federation's account for seniors and individually or through federation for Masters.

If the National federation has not yet an account pls contact CMAS admin at joaojose@cmas.org
The World Masters Championship will occur over the same competition days but Masters will apply for individual registration at the cmas portal. Age Categories are as defined at the relevant CMAS freediving rules.

National federations must register the actual official performances of all selected athletes to cmas portal. If there is not existing an official performance it will count as zero (0)

Please carefully take note of the following important points:

1. No Modifications to Assigned Disciplines:

Once registration has closed, no changes to the disciplines assigned to athletes will be accepted. This includes switching, adding, or removing events.

2. No Additional Disciplines:

Athletes will only be entered in the disciplines they were registered for within the official deadlines. No additional disciplines will be accepted at a later stage.

3. Declared Personal Bests (PBs) as Zero:

Athletes who declared a PB of "0" (zero) in any discipline and there is no official result registered in CMAS competitions, will be placed at the beginning of the start list, ordered alphabetically.

4. Reminder – Penalty for DNS (Did Not Start):

According to CMAS Depth Freediving Rules, article 1.3.1.3, In case of no show during the World Championships, the athletes will be declared DNS and a penalty of 300 euros will be applied to the team or individually for masters.

MEDICAL SERVICES

Medical Support & Emergency Procedures

On-Site Medical Coverage: Qualified medical doctors will be present throughout the competition to provide immediate first aid and initial medical support.

Emergency Transport: In the event of more serious medical situations, an ambulance will be stationed at the shore to facilitate rapid transfer to the nearest public hospital.

Responsibility for Off-Venue Incidents: Any health issues or injuries occurring outside the designated competition area are the responsibility of the individual athletes or their teams, including transportation and medical care arrangements.

Medical Expenses: All medical and hospital expenses are the responsibility of the athletes or their teams. The organizing committee does not cover these costs.

Diving-Related Accidents: In the event of any accident occurring during a dive, the athlete must undergo a medical evaluation at the local hospital. Further participation or travel will only be permitted upon clearance by the attending medical professionals in accordance with the established medical protocol.

INSURANCE

All teams must ensure that all their participants have adequate private health and repatriation insurance during 2025 CMAS WORLD CHAMPIONSHIP FREEDIVING OUTDOOR Mytikas Greece. The participants should purchase adequate medical insurance and repatriation insurance at their place of departure. The medical insurance shall at least cover accidental medical treatment, sudden illness and hospitalization allowance.

The repatriation insurance shall cover the costs in case of an emergency where you need to return to your place of departure. All participants must have valid insurance and provide the insurance certificate upon request. CMAS, Greek federation and Organizing committee will not be liable for any risks arising therefrom.

REFUND POLICY

- 1) Requesting Removal from the competition
- 1a. Teams or athletes requesting to be removed from the competition need to do so via email to LOC, by the captain or the coach of the team. We will use the date and time stamp as verification to when the request was sent. Phone calls, messages and texts will not be accepted.
- 1b. Any team or athlete that requests to be removed from the competition, before 30 days of the start date of the competition, will be removed with no administration fees accessed and full refund.
- 1c. Any team that requests removal from the competition 30 days or less from the start date, will have a euro 100 per person, administration fee, deducted from their entry fee. The refund will be 50% of the remaining amount.
 - 1d. No refund will be issued for hotel or transfer expenses if less than 30 days.
- 2) No refund will be issued to any team or athlete that requests removal from the competition 10 days or less from the start date of the competition.
- 3) Non-paid teams or athletes will not be allowed to participate until the fee is paid.

HOTELS

Teams, officials, athletes and Participants will be accommodated in several hotels and the booking will be selected and decided from the National teams as well as the booking arrangements and payments. The selection of each hotel and the payment of the hotels will be directly from each National team to hotels or booking platforms.

Pls take care for early booking because August-September is full season for Mytikas hotels and the availability will be limited.

We have reserve for the competition some hotels, rooms and apartments, in cooperation with local community and municipality. Even so September is full period, so pls contact as earlier directly for booking the rooms and hotels at the above website.
